**SUBJECT : LIST OF REGISTERED INTERNATIONAL/DOMESTIC  
SUGAR TRADERS**

This Office hereby issues the 3<sup>rd</sup> listing of registered International/Domestic sugar traders with the Sugar Regulatory Administration (SRA) for Crop Year 2015-2016.

Sugar mill companies and Mill District Regulation Officers are hereby advised that only persons and entities duly registered with the Sugar Regulatory Administration as International/Domestic sugar traders are authorized to withdraw sugar for export and domestic use from the warehouses of mill companies and sugar refineries in accordance with the existing rules and regulations promulgated by this Office.

Sugar producers may withdraw from their respective shares of their own sugar production from mill/refinery warehouses for their own domestic/local consumption only in the quantity of three (3) Lkg/bag per family per crop year.
