**SUBJECT : LIST OF REGISTERED INTERNATIONAL/DOMESTIC
MOLASSES/ MUSCOVADO TRADERS**

This Office hereby issues the First listing of registered International/Domestic molasses/ muscovado traders with the Sugar Regulatory Administration (SRA) for Crop Year 2016 - 2017.

Sugar mill companies and Mill District Regulation Officers are hereby advised that only persons and entities duly registered with the Sugar Regulatory Administration as International/Domestic molasses/muscovado traders are authorized to withdraw molasses for export and domestic use from the storage tanks of mill companies and sugar refineries in accordance with the existing rules and regulations promulgated by this Office.

Sugar producers may withdraw their respective shares of their own molasses production from mill/refinery storage tanks for domestic/local consumption only.
