SUBJECT: VERIFICATION OF "A" U. S. QUOTA SUGAR PRODUCED IN CROP YEAR 2018-2019 AND PRIOR YEARS

WHEREAS, the Sugar Regulatory Administration, in the exercise of its regulatory functions and for the purpose of ensuring the Philippine compliance with its U.S. Quota allocations, issued several Sugar Orders setting for the deadline for verification of "A" U.S. Quota Sugar for a particular crop year;

WHEREAS, the verification of "A" U. S. Quota Sugar is a long established system by which all sugar produced under the foregoing class is accounted for, purposely to determine our capability to perform our U.S. Quota allocations;

WHEREAS, the Sugar Regulatory Administration has determined that for the purpose of proper monitoring and accounting of all remaining and unshipped "A" U.S. Quota Sugar, there is a need for verification of all "A" U. S. Quota Sugar produced in CY 2018-2019 and CY 2017-2018;

NOW, THEREFORE, under and by virtue of the regulatory powers vested in the Sugar Regulatory Administration, it is hereby ordered that:

Section 1. Coverage of Verification. "A" U. S. Quota Sugar quedans-permits issued for Crop Year 2018-2019 and Crop Year 2017-2018, regular, reinstated and swapped are eligible for verification under this Sugar Order.

Section 2. Deadline for Verification. Hereunder is the scheduled deadline for verification of "A" U.S. Quota Sugar quedans:

WEEK ENDING	DEADLINE OF VERIFICATION
Crop Year 2017-2018	June 15, 2019
Sept. 1, 2018 - April 30, 2019	June 15, 2019
May 5 - May 26, 2019	June 30, 2019
June 2, 2019 - End of Milling	To be announced through a Circular Letter

Section 3. Failure to verify the "A" U. S. Quota Sugar subject of this Order shall result in the classification of sugar as "Homeless" quedans and its covering sugar is non-status, non-negotiable or marketable and cannot be withdrawn from the mills unless specifically authorized by SRA.

Section 4. Application for verification shall be filed at the Regulation Department, SRA, Quezon City.

Section 5. This Sugar Order shall take effect immediately upon its publication.

Section 6. Provisions of Sugar Orders, Circular Letters and/or other rules and regulations contrary to or inconsistent with this Sugar Order are hereby amended, modified or revoked.
