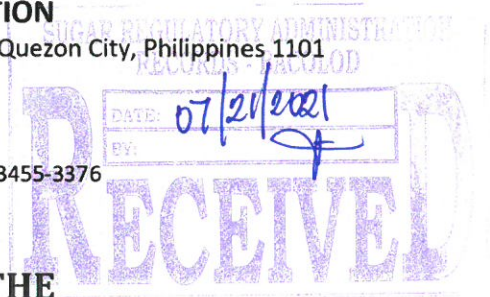

INVITATION TO BID FOR THE SUPPLY OF SECURITY SERVICES FOR THREE YEARS 2021-COB-01

1. The Sugar Regulatory Administration, through the funding year 2021 intends to apply the sum of PhP7,309,302.00 being the ABC to payments under the contract for Supply of Security Services for Three Years. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The Sugar Regulatory Administration now invites bids for Supply of Security Services for Three Years. Delivery of the Goods is required by October 1, 2021. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 IRR of RA No. 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Interested Bidders may obtain further information from Sugar Regulatory Administration and inspect the Bidding Documents at the address given below during 8:00 a.m. - 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on July 20, 2021 from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP 7,000. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The Sugar Regulatory Administration will hold a Pre-Bid Conference on July 28, 2021 9:00 A.M. at SRA Bacolod Conference Room for SRA RBAC only and/or through videoconferencing/web-casting via video conferencing only for prospective bidders, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below. on or before August 9, 2021 9:00 A.M. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on August 9, 2021 9:30 A.M. at the given address below and/or via video conferencing only for prospective bidders. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

10. The Supply of Security Services is required in SRA-Bacolod and SRA-LGAREC properties as stated in the Technical Specifications. The ABC indicated is for the first year only.

11. The Sugar Regulatory Administration reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 revised IRR RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
