SRA CSR and SUGAREAP Relief Operations for Taal Eruption Victims

The Sugar Regulatory Administration Corporate Social Responsibility (SRA CSR) Committee, together with the Sugar Regulatory Administration Employees Association of the Philippines, Inc. (SUGAREAP), held relief operations for the victims of Taal volcano eruption on January 22, 2020.



After 42 years, the Taal Volcano erupted on January 12, 2020¹. The Philippine Institute of Volcanology and Seismology (PHIVOLCS) raised the alert status to 4 due to the phreatic eruption being displayed by the volcano. This eruption was accompanied by volcanic earthquakes that resulted to the presence of fissures destroying some houses in parts of Batangas.² This led authorities to put the municipalities of Talisay, Agoncillo, San Nicolas, Taal, and Lemery under lockdown. As such, numerous residents and families took refuge in nearby evacuation centers for their safety.

To the rescue are the SRA CSR Committee and SUGAREAP volunteers. The volunteers went to different evacuation centers to give bottled water, packed goods, face towels, blankets, medicine supplies, rechargeable flashlights as well as hygiene

These relief operations for the Taal volcano eruption victims are in line with the SRA CSR's objective of promoting volunteerism and altruism³. Also, this is SRA's act of giving back to our stakeholders – the sugarcane planters and general public⁴, whom the SRA deems important to assist during these difficult times.
