Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of One Million Seven Hundred Ninety Thousand Pesos (₱1,790,000.00), or such other sums as may be ascertained, FIL POWER GROUP AND MARKETING CORP. agrees to supply, deliver and install One (1) Lot Generating Set in accordance with his/her/its Bid.
- 4. The **SUGAR REGULATORY ADMINISTRATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
