

Justification for Correction of Bench Length from 2500 mm to 2300 mm

During the review of the Purchase Request (PR) for the Laboratory Working Bench for General Use, a discrepancy was noted between the typed length value and the dimension shown in the attached diagram.

The length was typed as 2500 mm in the PR, while the attached technical diagram clearly indicated a length of 2300 mm. The figure 2500 mm was mistakenly entered instead of the correct 2300 mm as reflected in the original design.
