- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of *Three Million Two Hundred Eighty Thousand Pesos* (₱3,280,000.00) or such other sums as may be ascertained, ALL CERTIFIED EQUIPMENT TRADING CORPORATION agrees to supply and deliver one (1) unit 90hp tractor with farm implements in accordance with his/her/its Bid.
- 4. The **SUGAR REGULATORY ADMINISTRATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
