Erratum - Change in amount of the lowest bid for Top Loading Balance

I am writing to provide a formal justification regarding the recent erratum issued on July 15, 2024 concerning the change in the amount of the lowest bid for Top loading balance with AQ 2024-0744 & PR No. 2024-02-0310.

During the post-evaluation phase of the supplier selection process, it was identified that a clerical error occurred in the preparation of the abstract of quotations. Specifically, an incorrect tabulation or misinterpretation of the quotation price led to an erroneous determination of the winning supplier. This error was detected only after a thorough review of the documentation by the Accounting division, where it became clear that the lowest bidder should be CAPITAL MEDICAL SUPPLIES, not the previously announced supplier.

The error in the abstract affected the final assessment of the suppliers' submissions and, as a result, impacted the final award decision. However, after thorough review and consideration, it has been determined that the award should be retained with the originally selected winning supplier, **STARLAB MEDICAL AND SCIENTIFIC APPARATUS SUPPLY**, despite the fact that their bid was not the lowest. This decision was made based on the fact that the award was already posted on the PhilGEPS website, and the end-user has confirmed their satisfaction with the proposed balance.

We acknowledge that the winning supplier's bid was not the lowest (second lowest only) among all submitted proposals, but after considering the end-user's preference and the fact that the award process was already publicized, we have decided to proceed with the existing award.

I fully recognize the importance of transparency and fairness in our procurement processes and wish to reassure all parties involved that the selection process was conducted with the utmost integrity. The revision is being made in compliance with our internal guidelines and procurement policies to ensure that the correct supplier is awarded the contract.

I understand that such errors may cause concern, and I apologize for any confusion or inconvenience this may have caused. I am committed to ensuring that such errors do not occur in future procurement processes and will be reviewing our internal procedures to prevent recurrence.
