- In consideration for the sum of Three Million Four Hundred Twenty-Six Thousand Eighteen Pesos (Php3,426,018.00), or such other sums as may be ascertained, BCG ENTERPRISES agrees to supply and deliver forty-seven (47) units Desktop Computers in accordance with his/her/its Bid.
- The SUGAR REGULATORY ADMINISTRATION agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


