- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Six Hundred Seventeen Thousand Eight Hundred Fifty Pesos (₱617,850.00), or such other sums as may be ascertained, GBS TECHNOLOGIES OPC agrees to supply and deliver IT Equipment Lot C. Forty-Five (45) units Inkjet Printer in accordance with his/her/its Bid.
