FULL IMPOSITION AND COLLECTION ON THE INCREASE IN FEES AND CHARGES OF THE SEVEN (7) DEFERRED SRA FRONTLINE SERVICES UNDER GENERAL ADMINISTRATIVE

ORDER NO. 1, DATED 11 MAY 2011.

WHEREAS, Section 54 (I), Chapter 12, Book IV of Executive Order No. 292 (Administrative Code of 1987) provides that head of bureaus, offices or agencies upon the approval of the concerned department head, have the continuing authority to revise their rates of fees and charges and government owned and/or controlled corporations exercise the same authority pursuant to their respective charters

WHEREAS, the delivery of services to the people, through the various national government agencies and/or the regulation of certain activities with national interest, entails costs to the government, and equity requires that persons receiving or benefitting from rendered services share the cost of providing such services, hence, the imposition of fees and charges the primary purpose of which is cost recovery;

WHEREAS, the Sugar Regulatory Administration (SRA) was created on 28 May 1986 by virtue of Executive Order No. 18 in pursuit of the policy of the State "to promote the growth and development of the sugar industry through greater and significant participation of the private sector and to improve the working conditions of the laborers";

WHEREAS, Section 3 (g) of Executive Order No. 18 dated 28 May 1986 vests the SRA with the power to issue permits and licenses and collect corresponding fees and levies on the processing and manufacture of sugar and its by-products and other products derived from sugarcane and sugar;

WHEREAS, recognizing the need to revise the rates of fees and charges of its frontline services in the exercise of its' regulatory mandate pursuant to Executive Order No. 18, SRA issued on 11 May 2011 General Administrative Order No. 1 increasing the fees and charges of SRA frontline services which was last revised in the year 2003;

WHEREAS, prompted by the request of some stakeholders in the industry to maintain its present rate and/or to reduce the increase in fees and charges of seven (7) frontline services, SRA issued Memorandum Circular No. 1, Series of 2011 - 2012 on 26 August 2011 providing for the

deferment on the imposition and collection of the **increase** of fees and charges but only on the seven (7) frontline services, to wit;

- 1. Clearance fee for imported molasses
- 2. Clearance fee for export of Muscovado/application
- 3. Premix clearance (sucrose content Not Detectable (ND) or Zero (0)
- 4. Regular swapping fee
- 5. Monitoring fee of all sugar covered by Raw Sugar Quedan
- 6. Shipping permit
- 7. Milling permit

WHEREAS, Section 1, of SRA Memorandum Circular No. 11 dated 19 December 2016 provides for the partial implementation for the increase in fees and charges of two (2) frontline services and which shall be gradually increased until the maximum/full increase is attained. Further in Section 3, the increase in fees shall take effect January 1, 2017 and shall cover only the following, to wit:

Shipping Permit Fee	PhP 1.00 / Lkg-Bag	PhP 1.50 / Lkg-Bag

WHEREAS, Section 1 of SRA Sugar Order No. 5, Series of 2022-2023 ordered the discontinuance of the mandatory collection of Bioethanol Research, Development and Extension (BRDE) lien levied under Sugar Order No. 5, Series of 2015-2016 effective January 2023, and all (future) payments including past due accounts, if any, shall be paid directly or remitted to EPAP under its authority or discretion.

NOW, THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), the following is hereby ordered:

Section 1. Full Implementation on the Increase of Fees and Charges.

The **increase** in fees and charges of the seven (7) SRA frontline services included in the General Administrative Order No. 1, dated 11 May 2011 hereto attached, and the full collection of which were **deferred** by Memorandum Circular No. 1, Series of 2011 – 2012 dated 26 August 2011, are hereby fully implemented, imposed and collected, to wit:

Shipping Permit Fee, per Lkg-bag	3.00
Milling Permit Fee, per Lkg-bag	0.80

Section 2. All other fees and charges not covered by this Order shall remain in full force and effect.

Section 3. This Order shall take effect fifteen (15) days after publication.

FRONTLINE SERVICES

Pursuant to Memorandum Circular No. 137 of the Office of the President and Administrative Code of 1987 (Executive Order No. 292) which provides that heads of bureaus, offices or agencies, upon approval of the concerned department head, have the continuing authority to revise their rates of fees and charges to recover the cost of the service rendered and by virtue of the powers vested in the Sugar Regulatory Administration pursuant to Executive Order No. 18, through SRA Board Regulation No. 2011-274 dated March 8, 2011 approving the increase of rates of frontline services, it is hereby ordered that:

Section 1. These fees and charges are not intended to recover the administrative cost of services rendered.

Section 2. The increase in fees and charges of the frontline services in the exercise of the regulatory mandate of SRA pursuant to Executive Order No. 18 to regulate the schedule of charges are hereby imposed and collected as part of the SRA's regulatory function. The following are hereby increased and new rates shall be imposed and collected, as shown in Table 1 below.

All other fees and charges currently being charged and collected and not covered by this Order shall continue to be collected.

Section 4. This Order shall take effect fifteen (15) days after publication.

INCREASE IN FEES AND CHARGES OF SRA FRONTLINE SERVICES FOR CY 2011 -2012

WHEREAS, General Administrative Order No. 1 dated 11 May 2011 provides for an increase in fees and charges of SRA frontline services:

WHEREAS, there is a need to revise the rates of fees and charges (last Increase was year 2003) of the frontline services in the exercise of the regulatory mandate of the SRA pursuant to Executive Order No. 18;

NOW, THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), the following is hereby ordered:

Section 1. Increase in Fees and Charges.

The increase and new rates in fees and charges of the SRA frontline services enumerated in the General Administrative Order No. 1, dated 11 May 2011, as per attached hereto, are hereby imposed and collected except for the following which increases shall be deferred until further notice:

- Clearance fee for imported molasses 1.1
- Clearance fee for export of muscovado/application 1.2
- Premix clearance (sucrose content Not Detectable 1.3 (ND) or 0)
- Regular swapping fee 1.4
- Monitoring fee of all sugar covered by 1.5 Raw Sugar Quedan
- Shipping permit and 1.6
- Milling permit 1.7

- **Section 2.** This Sugar Order shall take effect beginning September 01, 2011 of Crop Year 2011-2012.
- **Section 3.** All other fees and charges not covered by this Order shall remain in full force and effect.
- **Section 4.** Provisions of Sugar Orders, Circular Letters and rules and regulations contrary or inconsistent with this Sugar Order are hereby revised, modified or revoked accordingly.
