CONTRACT AGREEMENT

THIS AGREEMENT made the day of CT 0 4 202 20 between Sugar Regulatory Administration of the Philippines (hereinafter called "the Entity") of the one part and Smart Communications, Inc. of Makati City, Philippines (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the Supply and Delivery of a Two (2)-Year Contract for the Subscription of Official Cellular Plans (Airtime Plans) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Five Million Three Hundred Ninety-Two Thousand Eight Hundred Pesos (PHP 5,392,800.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
