Query 1	In the discrepancy of ITB Clause 19.0, Item 19.1 and ITB Clause 20.0, Item 20.2 for Sealing of envelope, what provision should be allowed?
RBAC's Reply	ITB Clauses 19.0, 19.1 and 20.0 are maintained. Section 3 of GPPB Resolution No. 09-2020 (<i>Approving Measures for the Efficient Conduct of Procurement</i> <i>Activities During a State of Calamity, Or Implementation of Community</i> <i>Quarantine or Similar Restrictions</i>) does not authorize the submission and receipt of bids through electronic email or facsimile but only through electronic means by an online bidding facility or portal of which the Sugar Regulatory <i>Administration is currently not capable yet.</i>
Query 2	To adjust the delivery period from 60 calendar days to 120 calendar days
RBAC's Reply	Request DENIED. Time constraints, since SRA's budget is still waiting for the approval by the DBM. The budget needs to be utilized before the end of the year as required by cash-based budgeting. Further, procuring entities are instructed to only cover projects that can be implemented this year (Section 1 of GPPB Resolution No. 09-2020).
Query 3	In lieu of the local owner notarized affidavit for having purchased of the Tractor for the past 35 years, a son, daughter, granddaughter or grandson can attest to the fact the same.
