INVITATION TO BID FOR THE SALE OF UNSERVICEABLE PROPERTIES

1. The Sugar Regulatory Administration (SRA), through its Asset Management and Disposal Committee (AMDC), hereby invites all interested parties to participate in the public auction through Sealed Public Bidding, for the sale of various unserviceable properties on an "as-is-where-is" basis as indicated below:

- 2. Prospective bidders may inspect the items for sale from 8:30 a.m. to 3:30 p.m. on May 21 to 27, 2025.
- 3. A complete set of bidding documents can be acquired from the AMDC Secretariat at the 4th Floor, SRA Main Building, North Avenue Diliman, Quezon City from May 21 to 27, 2025.
- 4. An auction bond equivalent to ten percent (10%) of the floor price in the form of cash or manager's/cashier's check from a commercial or universal bank must be submitted together with the bid.
- 5. The properly signed bid offer or auction tender must be submitted to the AMDC Secretariat at the 4th Floor, SRA Main Building, North Avenue Diliman, Quezon City in three (3) copies together with the other required documents, in a sealed and marked envelope address to the AMDC Chairperson. The AMDC shall not be responsible for any tampering of unsealed bids.
- 6. Deadline for submission of bids is at 9:00 a.m. on May 28, 2025. Late bids shall not be accepted.
- 7. A bidder may withdraw his/her bid after it has been submitted for valid and justifiable reason, provided that the Letter of Withdrawal is received by the AMDC prior to the deadline for submission of bids. Modification/withdrawal of bids shall not be allowed after the deadline.







- 8. Opening of bids is on May 28, 2025, 9:30 a.m. at the Social Hall, Sugar Regulatory Administration, North Avenue, Diliman, Quezon City.
- 9. Bids will be opened in the presence of all the bidders or their duly designated representatives and the COA representative. Auction tenders that are not in the prescribed form and/or not accompanied by auction bonds and qualification documents at the time of opening of bids are considered defective, hence, shall be automatically disqualified.
- 10. The bid bond of non-winning bidders shall be returned outright. Bid offer/s shall be valid for sixty (60) calendar days.
- 11. One-time payment in the form of cash, cashier's check or manager's check or any other digital modes shall be made within five (5) working days from the date of receipt of the Notice of Award. The bid bond shall be forfeited in favor of the SRA if the winning bidder refuses to accept the award and in case the winning bidder fails to make the payment within the prescribed period.
- 12. The winning bidder shall be given five (5) working days from the full payment of the bid price, to pick-up and haul the properties. Expenses incidental to the pickup/hauling of the properties shall be borne by the winning bidder.
- 13. Failure of bidding shall be declared if no bids were received or if all bidders failed to comply with the terms and conditions in the Invitation to Bid and Instruction to Bidders.
- 14. The Sugar Regulatory Administration (SRA) reserves the right to reject any or all bids and to annul the bidding process any time prior to the award of contract, without hereby incurring any liability to the affected bidder or bidders or any obligation to inform affected bidder or bidders of the grounds for the SRA's actions.
- 15. Let copies of this Invitation be posted from May 21 to 27, 2025 to at least three (3) conspicuous areas within and outside of SRA, and on the SRA website in order to invite qualified bidders.
