INVITATION TO BID FOR

THE SUPPLY AND DELIVERY OF ONE (1) UNIT BRAND NEW MULTI-PURPOSE VEHICLE (MPV)

- 1. The Sugar Regulatory Administration (SRA), through the 2022 SRA COB-SIDA Budget intends to apply the sum of One Million Six Hundred Fifty Thousand Pesos (Php1,650,000.00) being the Approved Budget for the Contract (ABC) to payments under the Contract for the Supply and Delivery of One (1) Unit Brand New Multi-Purpose Vehicle (MPV). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Sugar Regulatory Administration (SRA) now invites bids for the above Procurement Project. Delivery of the Goods is required by ninety (90) calendar days from receipt of the Notice to Proceed (NTP). Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from BAC Secretariat, Sugar Regulatory Administration (SRA) and inspect the Bidding Documents at the address given below during 8:00 AM 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on July 15, 2022 to August 08, 2022 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees through a copy of Official Receipt (OR) to be presented at the Authorized Representative.

- 10. No bidder shall "Deal Secretly" or give commission to any SRA Officers/Employees pursuant to SRA Memorandum dated September 8, 2016. Violation of this restriction shall be a ground for disqualification.

The Sugar Regulatory Administration (SRA) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
