## INVITATION TO BID FOR SUPPLY AND DELIVERY OF VARIOUS GROCERY ITEMS FOR FOOD PACK DISTRIBUTION 2022-COB-02

- 1. The SUGAR REGULATORY ADMINISTRATION, through the Corporate Operating Budget 2022 intends to apply the sum of Four Million Five Hundred Thousand Pesos (\$\mathbb{P}4.500,000.00)\$ being the ABC to payments under the contract for the Supply and Delivery of Various Grocery Items for Food Pack Distribution / 2022-COB-02. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The SUGAR REGULATORY ADMINISTRATION now invites bids for the above Procurement Project. Delivery of the Goods is required by on or before December 21, 2022 but not earlier than December 16, 2022. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from SUGAR REGULATORY 4. ADMINISTRATION and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M.
- A complete set of Bidding Documents may be acquired by interested Bidders on 5. November 22, 2022 until December 13, 2022 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ₱ 4,500.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

This shall be open to prospective bidders who shall have the option to attend either physically or through video conferencing via the Zoom platform.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before December 13, 2022; 9:00 A.M. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on December 13, 2022; 9:30 A.M. at the given address below and will be made available via Zoom platform for those who choose to attend virtually. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The SUGAR REGULATORY ADMINISTRATION reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
