INVITATION TO BID

SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR THE STRUCTURAL RETROFITTING OF THE SUGAR REGULATORY ADMINISTRATION (SRA) MAIN AND ANNEX BUILDINGS

- 1. The Sugar Regulatory Administration (SRA), through the 2020 SRA Corporate Operating Budget (COB) intends to apply the sum of Sixty Eight Million Twelve Thousand Nine Hundred Fifty Eight Pesos and 72/100 (Php68,012,958.72) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply of Labor, Materials and Equipment for the Structural Retrofitting of the Sugar Regulatory Administration (SRA) Main and Annex Buildings. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Sugar Regulatory Administration (SRA) now invites bids for the Supply of Labor, Materials and Equipment for the Structural Retrofitting of the Sugar Regulatory Administration (SRA) Main and Annex Buildings. Completion of the Works is required within two (2) years. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from BAC Secretariat, Sugar Regulatory Administration (SRA) and inspect the Bidding Documents at the address given below from 8:00 AM 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on March 11, 2020 to April 03, 2020 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 50,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The Sugar Regulatory Administration (SRA) will hold a Pre-Bid Conference on March 18, 2020 / 9:00 AM at SRA Social Hall, Sugar Regulatory Administration (SRA), North Avenue, Diliman, Quezon City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before **April 03, 2020 / 9:00 AM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on April 03, 2020 / 9:00 AM at SRA Social Hall, Sugar Regulatory Administration (SRA), North Avenue, Diliman, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. No bidder shall "Deal Secretly or give commission to any SRA Officers/Employees pursuant to SRA Memorandum dated September 8, 2016. Violation of this restriction shall be a ground for disqualification.
- 9. The **Sugar Regulatory Administration (SRA)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
