- 1. The Sugar Regulatory Administration, through the funding year 2021 intends to apply the sum of PhP5,400,000.00 for Pick-up Truck, PhP1,600,000.00 for SUV (Monitoring Vehicle), PhP9,000,000.00 for Flat Bed Truck, being the ABC to payments under the contract for each lot/item. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
- 2. The Sugar Regulatory Administration now invites bids for Supply and Delivery of Vehicles (Short of Award). Delivery of the Goods is required by December 29, 2021. Bidders should have completed, within Five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 IRR of RA No. 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Interested Bidders may obtain further information from Sugar Regulatory Administration and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on September 22, 2021 from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP 16,000. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 6. The Sugar Regulatory Administration will hold a Pre-Bid Conference on September 30, 2021, 1:30 PM at SRA Bacolod Conference Room and/or through videoconferencing/web-casting via Microsoft Teams platform. Link will be provided, which shall be open to prospective bidders.


