Invitation to Bid for the Procurement of Supply and Delivery of One (1) Unit Brand New UV-VIS Spectrophotometer

1. The *Sugar Regulatory Administration (SRA)*, through the *2025 SRA Corporate Operating Budget (COB)* intends to apply the sum of *One Million Pesos (Php 1,000,000.00)* being the ABC to payments under the contract for the **Procurement of Supply and Delivery of One (1) Unit Brand New UV-VIS Spectrophotometer**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *SRA* now invites bids for the above Procurement Project. Delivery of the Goods is required by *Ninety (90) Calendar Days from receipt of the Notice to Proceed (NTP)*. Bidders should have completed, within *Five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from the *SRA BAC Secretariat* and inspect the Bidding Documents at the address given below during **8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **April 4, 2025 to April 28, 2025** from the given address and website(s) below, *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 1,000.00*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees such as a copy of the Official Receipt (OR) issued by the SRA Cashier.

Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
