 Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a

- Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before October 17, 2024, 9:30 AM. Late bids shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on October 17, 2024, 9:30 AM at the given address below SRA Social Hall, Sugar Regulatory Administration (SRA), North Avenue, Diliman, Quezon City through physical or face-to-face. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. No bidder shall "Deal Secretly" or give commission to any SRA Officers/Employees pursuant to SRA Memorandum dated September 8, 2016. Violation of this restriction shall be a ground for disqualification.
