INVITATION TO BID

EARLY PROCUREMENT ACTIVITY FOR SUPPLY AND DELIVERY OF ONE (1) UNIT CARBON-NITROGEN-SULFUR (CNS) ANALYZER

- The Sugar Regulatory Administration (SRA), through the 2025 SRA SIDA Budget intends to apply the sum of Four Million Five Hundred Thousand Pesos (Php4,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the Contract for the Early Procurement Activity for Supply and Delivery of One (1) Unit Carbon-Nitrogen-Sulfur (CNS) Analyzer. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The Sugar Regulatory Administration (SRA) now invites bids for the Activity for Supply and Delivery of One (1) Unit Carbon-Nitrogen-Sulfur (CNS) Analyzer, as described below:

Delivery of the Goods is required by sixty (60) calendar days from receipt of the Notice to Proceed (NTP). Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

 Prospective Bidders may obtain further information from BAC Secretariat, Sugar Regulatory Administration (SRA) and inspect the Bidding Documents at the address given below during 8:00 AM - 5:00 PM.







- A complete set of Bidding Documents may be acquired by interested Bidders on **November 19, 2024 to December 10, 2024** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 5,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees through a copy of Official Receipt (OR) to be presented by the Authorized Representative.
- 6. The Sugar Regulatory Administration (SRA) will hold a Pre-Bid Conference on November 27, 2024, 1:30 PM at 3rd Floor IAD-QMS Room, Sugar Regulatory Administration (SRA), North Avenue, Diliman, Quezon City through physical or face-to-face, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **December 10, 2024, 1:30 PM**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on December 10, 2024, 1:30 PM at the given address below 3rd Floor IAD-QMS Room, Sugar Regulatory Administration (SRA), North Avenue, Diliman, Quezon City through physical or face-to-face. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. No bidder shall "Deal Secretly" or give commission to any SRA Officers/Employees pursuant to SRA Memorandum dated September 8, 2016. Violation of this restriction shall be a ground for disqualification.
- 11. The **Sugar Regulatory Administration (SRA)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
