Invitation to Bid for the Procurement of Supply, Delivery, and Administration of Pneumonia and Flu Vaccination Program for the Sugar Regulatory Administration (SRA)

- 1. The Sugar Regulatory Administration (SRA), through the 2025 SRA Corporate Operating Budget (COB) intends to apply the sum of One Million One Hundred Thousand Two Hundred Sixty-Six Pesos (Php 1,100,266.00) being the ABC to payments under the contract for the Procurement of Supply, Delivery, and Administration of Pneumonia and Flu Vaccination Program for the Sugar Regulatory Administration (SRA). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The SRA now invites bids for the above Procurement Project. Delivery and Administration of the Goods is required within ninety (90) Calendar Days from receipt of the Notice to Proceed (NTP). Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from the SRA BAC Secretariat and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on *June 18*, 2025 to July 18, 2025 from the given address and website(s) below, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees such as a copy of the Official Receipt (OR) issued by the SRA Cashier.

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before July 18, 2025. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on July 18, 2025 @9:30 AM at the given address below SRA Social Hall, Sugar Regulatory Administration, North Avenue, Diliman, Quezon City through Physical or Face-to-Face. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. No bidder shall "Deal Secretly" or give commission to any SRA Officers/Employees pursuant to SRA Memorandum dated September 8, 2016. Violation of this restriction shall be a ground for disqualification.

The SRA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
