The Sugar Regulatory Administration (SRA), through the 2024 SRA COB Budget intends to apply the sum of Three Million Seven Hundred Twenty-Four Thousand Two Hundred Fifty Pesos (Php 3,724,250.00) being the Approved Budget for the Contract (ABC) to payments under the Contract for the Supply and Delivery of Twenty-Four (24) Units Brand New Motorcycle (Re-bidding). Bids received in excess of the ABC shall be automatically rejected at bid opening.

 The Sugar Regulatory Administration (SRA) now invites bids for the Supply and Delivery of Twenty-Four (24) Units Brand New Motorcycle (Re-bidding), as described below:

Delivery of the Goods is required by **forty-five (45) calendar days from receipt of the Notice to Proceed (NTP).** Bidders should have completed, within **three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

A complete set of Bidding Documents may be acquired by interested Bidders on **December 13, 2024 to January 20, 2025** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees through a copy of Official Receipt (OR) to be presented to the Authorized Representative.
- 7. The **Sugar Regulatory Administration (SRA)** will hold a Pre-Bid Conference on **January 6, 2025, 09:30 AM** at **SRA Social Hall, Sugar Regulatory Administration (SRA), North Avenue, Diliman, Quezon City** through physical or face-to-face, which shall be open to prospective bidders.
- 8. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **January 20, 2025 9:30 AM**. Late bids shall not be accepted.
- 9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
