Sugar Order No. 13 Series of 2008 - 2009

> SUBJECT: AMENDMENT TO SECTION 2 OF SUGAR ORDER NO. 4-A, SERIES OF 2008-2009, AND PRESCRIBING THE REINSTATEMENT FEE FOR "A" SUGAR QUEDANS ISSUED IN PRIOR CROP YEARS TO THE PRESENT

WHEREAS, Sugar Order No. 4-A, Series of 2008-2009 allowed the verification of "A" sugar quedans issued in Crop Year 2008-2009 only;

WHEREAS, there is also a need to account the whereabouts of outstanding "A" sugar quedans issued in previous crop years, and ascertain the total available volume of all outstanding "A" quedans;

WHEREAS, requests for verification of "A" sugar quedan issued in previous crop years were received from holders of the same;

NOW THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), the following is hereby ordered:

Section 1. Amendment to Section 2 of Sugar Order No. 4-A, Series of 2008-2009. Section 2. Coverage of Sugar Order No. 4-A, Series of 2008-2009 is amended as: "The verification shall cover all outstanding "A" sugar quedans, including quedans issued during the present and previous crop years. All "A" sugar quedans declared "HOMELESS" under Sugar Order No. 6, Series of 2007-2008 and similar sugar orders are now eligible for verification under this order."

Section 2. Reinstatement Fee. A one-time reinstatement fee of P50.00 per LKg-bag shall be charged for homeless "A" quedans produced in Crop Year 2007-2008, P60.00 per LKg-bag for Crop Year 2006-2007, P70.00 per LKg-bag for Crop Year 2005-2006, and P80.00 per LKg-bag for all prior crop years.

Section 3. Deadline for Reinstatement and Verification. "A" sugar quedans reinstated under Section 1 & 2 above must be verified for export to the United States on or before August 15, 2009. "A" sugar quedans not reinstated and verified by August 15, 2009 shall remain homeless and non-negotiable/non-marketable, and the same cannot be withdrawn from the mill.

Section 4. This Order shall take effect immediately.

Section 5. Provisions of Sugar Orders, Circular Letters, rules and regulations contrary to or inconsistent with this Sugar Order is hereby revised, modified or revoked.
