SUGAR ORDER NO. 13
Series of 2007-2008

**SUBJECT : DEADLINES FOR DISPOSING "D"
OR WORLD MARKET SUGAR**

WHEREAS, Section 2 (B) of Executive Order (EO) No. 18, Series of 1986 mandates the SRA to establish and maintain such balanced relation between production and requirement of sugar and such marketing conditions as will ensure stabilized prices at levels reasonably profitable to the producers and fair to consumers;

WHEREAS, Section 2 (C) of Executive Order (EO) No. 18, Series of 1986, further states that the Sugar Regulatory Administration (SRA) is created to promote the effective merchandising of sugar and its by-products in the domestic and foreign markets so that those engaged in the sugar industry will be placed on a basis of economic viability;

WHEREAS, pursuant to the above-cited provisions, the SRA in its Sugar Order Nos. 1-1-A, 1-B and 1-C, all Series of 2007-2008 has allocated a portion of the sugar production for "D" or World Market sugar and as of week ending June 22, 2008, out of the total 79,767MT "D" or World Market sugar produced for the crop year, only 14,351.77 MT (as of March 23, 2007) had been surrendered and issued clearance for export while 52,132.11 MT have been converted to "E" or CBW Processor/Exporter sugar;

WHEREAS, the "D" or World Market sugar is primarily intended for export to the world market to remove from the domestic market the excess sugar produced;

NOW THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), it is hereby ordered that:

Section 1. All "D" or World Market sugar produced in Crop Year 2007-2008 must either be sold/contracted/committed for sale to the Sugar-Based Food Manufacturers/Exporters or sold to the world market on or before **July 31, 2008**.

For this purpose, copies of contracts and other documentary proofs, including a copy of the list of "D" quedans arranged according to mills and week ending shall be submitted to the SRA Quezon City on or before August 8, 2008.

Section 2. Declaration of Homeless (expired) "D" quedans. "D" quedans which did not meet the deadline as mentioned in Sections 1 and 2 hereto shall be considered homeless (expired) and its status non-negotiable, non-marketable and cannot be withdrawn from the mills.

Section 3. Consistency. Provisions of Sugar Orders, Circular Letters, rules and regulations contrary to or inconsistent with this Sugar Order are hereby revised, modified or revoked accordingly.
