**SUBJECT: GENERAL GUIDELINES FOR THE REINSTATEMENT OF HOMELESS "A"
AND "D" QUEDANS**

WHEREAS, Sugar Order No. 13, Series of 2008-2009 declared that all homeless "A" sugar quedans not availing of the reinstatement provided therein by August 15, 2009 shall remain homeless and non-negotiable/non-marketable;

WHEREAS, Sugar Order No. 3, Series of 2008-2009 provided the guidelines for disposition of "D" World Market sugar for Export or for consumption of sugar-based food exporters, outlining therein the conditions for declaring "D" quedans as "Homeless", as well as that for its reinstatement, including the reinstatement fee of P10.00 per LKg-bag per day;

WHEREAS, Sugar Orders No. 8, 8-A, 11, and 12, all Series of 2008-2009, granted a moratorium on the imposition of the reinstatement fee of P10.00 per LKg-bag per day, and instead prescribed certain amounts for availing of the moratorium based on conditions set in each sugar order;

WHEREAS, requests to avail of the moratorium set forth in the above-stated sugar orders for the reinstatement of homeless "A" and "D" sugar quedans have been received past the deadline prescribed;

WHEREAS, the reinstatement of homeless "A" and "D" outside of any declared moratorium period needs to be properly managed;

NOW THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), the following is hereby ordered:

Section 1. Approval of Reinstatement. The approval of any request for reinstatement of "A" or "D" sugar quedans during times outside of a declared moratorium period will be the sole authority of the Sugar Board.

Section 2. Reinstatement Fees. Unless explicitly stated in a sugar order covering a moratorium, the reinstatement fees for homeless "A" and "D" sugar quedans shall be as follows:

For homeless "A" sugar quedans: P60.00 per Lkg-bag plus P1.00 per LKg-bag per day reckoned from the time it became homeless until the filing of the request for reinstatement.

For homeless "D" sugar quedans: P10.00 per LKg-bag per day reckoned from the time it became homeless until the filing of the request for reinstatement.

Section 3. This Order shall take effect immediately.

Section 4. Provisions of Sugar Orders, Circular Letters, rules and regulations contrary to or inconsistent with this Sugar Order is hereby revised, modified or revoked.
