Series of 2007-2008

SUBJECT : REINSTATEMENT OF "A" 'HOMELESS' SUGAR OF CROP  
YEAR 2006-2007 INTO "A" OR U. S. QUOTA SUGAR

WHEREAS, the allocation for the whole U.S. quota of 167,174 MTCW for Quota Year 2006-2007 had already been filled up;

WHEREAS, various sugar producers/traders had made an appeal with the SRA for reconsideration for verification of their "A" export sugar classified as "homeless" sugar pursuant to Sugar Order (S.O.) No. 7, and Circular Letter No. 28, Series of 2006-2007, wherein said verification is to reinstate the subject "A" 'homeless' sugar (for failure of their owners to have the covering "A" quedans verified for export during the specified schedule per said S.O.) into "A" or U.S. Quota sugar;

WHEREAS, the SRA is mandated by EO 18, Series of 1986, to protect the interest of the sugar industry in general and sugar producers in particular, without compromising our export commitment to the U.S. in terms of quality of the "A" sugar and its shipment schedule;

WHEREAS, Sugar Order No. 11, Series of 2006-2007 dated 23 May 2007 has already reinstated quedans which became homeless pursuant to Sugar Order No. 7, Series of 2006-2007;

NOW, THEREFORE, under and by virtue of the powers vested in the Sugar Regulatory Administration (SRA), it is hereby ordered that:

Section 1. The "A" sugar quedans which were declared as "A" 'homeless' sugar pursuant to Circular Letter No. 28, Series of 2006-2007 are hereby reinstated as "A" or U.S. Quota sugar.

Section 2. The "A" quedans covering the "A" 'homeless' sugar shall be subject for verification prior to its reinstatement as "A" or U.S. Quota sugar.

**Section 3.** The application for verification of the subject "A" quedans shall be filed with the SRA, Quezon City attached thereto the "A" quedans and the corresponding list by mill/ by quedan number.

**Section 4.** A reinstatement fee of PHP10.00 per Lkg-bag shall be paid upon filing of the application for verification with the SRA.

**Section 5.** All "A" quedans subject of verification shall be stamped at the back thereof as "Reinstated "A" 'homeless' sugar into "A" or U. S. Quota sugar per S. O. No. 5, Series of 2007-2008".

**Section 6. Deadline for verification of "A" quedans.** Deadline for verification of "A" quedans covered by this Sugar Order is on January 9, 2008. Thereafter, unverified quedans shall remain expired (homeless).

**Section 7. Effectivity.** This Order shall take effect immediately.

**Section 8. Consistency.** Provisions of Sugar Orders, Circular Letters, and/or other rules and regulations contrary to or inconsistent with this Sugar order, are hereby amended, modified or revoked accordingly.
