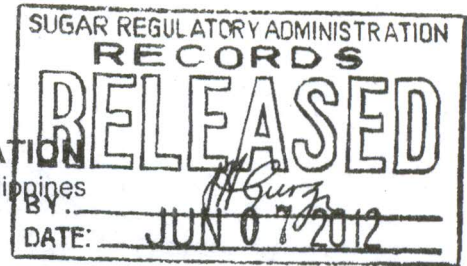

SUBJECT: PRINTING OF CROP YEAR 2012-2013 SUGAR QUEDAN FORMS

Sugar quedans, of the single sheet stub-quedan-permit format, both for raw and refined for Crop Year (CY) 2012-2013, are being prepared for printing. Mill companies and sugar refineries intending to revise their forms are hereby requested to submit their revised formats together with the duly accomplished Questionnaire hereto attached, to **SUGAR TRANSACTION DIVISION, Regulation Department**, Sugar Regulatory Administration, Sugar Center Building, North Avenue, Diliman, Quezon City, on or before:


1. JULY 18, 2012

For mills and refineries that will start their milling/refining operations between the period September and November, 2012 and

2. AUGUST 01, 2012

For mills and refineries that will start on December, 2012

After the aforesaid dates, this Office will order the printing of quedan-permit forms on the basis of each mill and refinery formats of CY 2011-2012, if no revisions were received.
