MAKING AVAILABLE THE "D" OR WORLD MARKET SUGAR FOR CBW/ FOOD PROCESSORS/MANUFACTURERS OF SUGAR-BASED PRODUCTS FOR EXPORT AND ACCREDITED ETHANOL PRODUCERS

WHEREAS, Section 2 C of Executive Order No. 18, Series of 1986, states that the SRA is created to promote the effective merchandising of sugar and its by-products in the domestic and foreign markets so that those engaged in the sugar industry will be placed on a basis of economic viability;

WHEREAS, Section 1 of Sugar Order No. 1, Series of 2017-2018, provides a 10% allocation of "D" or world market sugar produced during the CY 2017-2018;

WHEREAS, it is beneficial to provide readily available sugar to food processors/ manufacturers of sugar-based products for export in order to remain competitive in the world market;

WHEREAS, SRA has previously allowed "D" or World Market sugar to be reclassified as "E" sugar to be used by the food processors/manufacturers of sugar-based products for export as well as "F" sugar to be used by accredited ethanol producers;

NOW, THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration, it is hereby ordered that:

Section 1. The "D" world market sugar produced during the current sugar crop year 2017-2018 is hereby made available to: 1) food processors/manufacturers of sugar-based products for export who are accredited member of the Customs Bonded Warehouse (CBW) with SRA allocation, classified as "E" and 2) ethanol producers accredited by the SRA, classified as "F".

Section 2. The Implementing Rules and Regulations (IRR) in the availment of "D" World market sugar by the food processors/manufacturers of sugar-based products for exports per Circular Letter No. 25, Series of 2016-2017 and the requirements for reclassification of "D" world market sugar to "F" or fermentable sugar per Sugar Order No. 5, Series of 2008-2009 shall apply.

Section 3. The application for export shipment to the world market, food processors/manufacturers of sugar-based products for export and fermentable sugar-based filed at the Regulation Department, SRA, Quezon City.
