- Specifications of the Sugarcane Grabber-Loader to be submitted by the bidder should be signed and sealed by a registered professional Agricultural Engineer.
- Delivery on site.
- After sales service is required in the region where the Implements are delivered.
- All delivery cost shall be at the expense of the Supplier.

Submit valid and current certificate of distributorship/dealership/re-sellership of the product being offered, issued by the principal or the manufacturer of the product (if bidder is not the manufacturer). If not issued by manufacturer, must also submit certification/document linking bidder to the manufacturer or authorization letter from the manufacturer or authorized distributor indicating that the bidder is authorized to submit a bid and subsequently negotiate and sign contract and extend full guarantee and warranty for the goods being offered.
