**SUBJECT : Amendment to Sugar Order No. 8, Series of 2012-2013**  
**Re : Harmonizing the Fees and Penalty Charges**  
**on Advance Refining**

**WHEREAS**, there is a need to amend certain provisions of Sugar Order No. 8, Series of 2012-2013 by also including the sugar traders, not only the integrated mills, in the practice of advance refining for their operational advantages and market considerations;

**NOW, THEREFORE**, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), it is hereby ordered that:

**Section 1.** Section 1.A.2.1 of Sugar Order No. 8, Series of 2012-2013 is hereby amended to read as follows:

**"Section 1.** Nature and Modes of Advance Refining

**A.2** Application for Approval of Request for Advance Refining

1. Requesting refineries and/or sugar traders must submit a letter-request for the advance refining of A and D sugars or both for SRA's approval. Provided, however that if a sugar trader will apply for advance refining, there shall be attached the **Conformity of the Concerned Refinery**.

All approvals shall be subject to the original terms and conditions".

**Section 2.** Other provisions of the aforesaid Sugar Order No. 8, Series of 2012-2013 shall remain in full force and effect.

**Section 3.** Provisions of sugar orders, circular letters, rules and regulations that are contrary to or inconsistent with this Order are hereby amended, modified or revoked accordingly.
