

## INVITATION TO BID FOR THE SUPPLY OF SECURITY SERVICES FOR THREE YEARS

- The SUGAR REGULATORY ADMINISTRATION, through the SRA Corporate Operating Budget for 2018 intends to apply the sum of Five Million Nine Hundred Sixty-Nine Thousand Nine Hundred Eighty-one and 66/100 Pesos (₱5,410,860.00) being the Approved Budget for the Contract (ABC) for the first year only of the Three-year Contract for the Supply of Security Services (CN2018-001). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The SUGAR REGULATORY ADMINISTRATION now invites bids for the Supply of Security Services for a period of three (3) years with 26 security guards to be stationed in SRA-Bacolod Office; the lot adjacent to the Cebu Pacific terminal (old airport area); LGAREC, La Granja, La Carlota City; Tulo-tulo, Brgy. Haguimit, La Carlota City; and such other places as maybe specified by SRA. The contract rate/guard based on the W.O. # RBVI 23 effective March 16, 2017 at 8 hours' work/day is Php17,342.50/month. Delivery of the Goods is required on October 1, 2018. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 5. Interested bidders may obtain further information from the SUGAR REGULATORY ADMINISTRATION and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.
- 6. A complete set of Bidding Documents may be acquired by interested Bidders from July 17 to August 6, 2018 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ₱5,000.00.
- 7. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 8. The SUGAR REGULATORY ADMINISTRATION will hold a Pre-Bid Conference on July 25, 2018, 9:00 a.m. at the SRA Conference Room, Sugar Regulatory Administration, Araneta St., Singcang, Bacolod City, which shall be open to prospective bidders.
- 9. Bids must be duly received by the BAC Secretariat at the address below on or before 9:00 a.m. August 6, 2018. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
- 10. Bid opening shall be on August 6, 2018; 9:00 a.m. at the SRA Conference room, Sugar Regulatory Administration, Araneta St., Singcang, Bacolod City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 11. The SUGAR REGULATORY ADMINISTRATION reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
