## INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF IT EQUIPMENT ITB No. 2018-09-20

1. The SUGAR REGULATORY ADMINISTRATION, through the SRA Corporate Operating Budget 2018 intends to apply the sum of Three Million Thirty-one Thousand Five Hundred Pesos (₱3,031,500.00) being the total Approved Budget for the Contract (ABC) to payments under the contract for the supply and delivery of Laboratory Equipment/SRAVIS-CN2018-013. Bids received in excess of the ABCs shall be automatically rejected at bid opening.
2. The SUGAR REGULATORY ADMINISTRATION now invites bids for the supply and delivery of various IT equipment stated below on a per lot basis. Delivery of the Goods is required 30 calendar days from receipt of the Purchase Order/Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the SUGAR REGULATORY ADMINISTRATION and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on September 13, 2018 to October 3, 2018 from the address below and upon payment of the applicable fees, stated on the second page, for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB.

7. Bids must be duly received by the BAC Secretariat at the address below on or before 9:00 a.m. October 3, 2018. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on October 3, 2018; 9:00 a.m. at the SRA Conference room, Sugar Regulatory Administration, Araneta St., Singcang, Bacolod City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The SUGAR REGULATORY ADMINISTRATION reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
