SUBJECT: REVISED APPLICATION FORM FOR LICENSE TO OPERATE (LTO) AS TRADER (FM-REG-LMD-001-REV.05 Effectivity date: May 24, 2019)

All trader applicants are hereby directed to use the revised Application Form for License to Operate as Trader (LTO). The revisions done are the Gender Selection box on the front page of the application form right beside (b) Proprietor, Managing Partner/President AND the additional requirements (Authorization letter and Company ID of the authorized representative from the owner to transact business) found on page two (2).

This is necessary to provide all traders the revised application forms and requirements needed for compliance prior approval of license for a given Crop Year.

The revised application form can be downloaded from the SRA Website www.sra.gov.ph. Previous application forms are considered invalid.

All Traders are advised to check all documents needed as part of the requirements to avoid delays in the processing of LTO. Applications with incomplete requiremetrs will no longer be accepted.

□ For Trader/Non-Producer of Organic Muscovado (Traders whose sources of Organic Cortificate issued by OCB to Muscovado Producers);  Organic Certificate issued by OCB to Muscovado Producers where the Trader/Non-Puill source its muscovado products for sale and distribution.	

The certificates issued by the OCB are valid only for one (1) year. For Trader/Producer of Muscovado whose products are declared as Organic and for Trader/Non-Producer of Organic Muscovado are required to secure OCB Certificate every year and submit the same to SRA two (2) months prior to the start of the Crop Year within the validity period of the Certificate of Registration (or COR) issued pursuant to Muscovado Order No. 2
