INVITATION TO BID FOR THE FERTILIZERS ITB 2019-08

1. The SUGAR REGULATORY ADMINISTRATION, through the SRA Corporate Operating Budget 2019 intends to apply the sum of One Million Fifty-Two Thousand Six Hundred Pesos (₱1,052,600.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the supply and delivery of one (1) lot of 345 bags 46-0-0; 283 bags 18-46-0; 163 bags 0-0-60; and 10 bags of 21-0-0/CN2019-003. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The SUGAR REGULATORY ADMINISTRATION now invites bids for the Supply and Delivery of one (1) lot of 345 bags 46-0-0; 283 bags 18-46-0; 163 bags 0-0-60; and 10 bags of 21-0-0 at 50kg/bag. Delivery of the Goods is required thirty (30) days upon receipt of Purchase Order at the Sugar Regulatory Administration, LGAREC, La Granja, La Carlota City. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the SUGAR REGULATORY ADMINISTRATION and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders June 10 – July 1, 2019 from the address stated on page 2 of this ITB and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ₱1,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The SUGAR REGULATORY ADMINISTRATION will hold a Pre-Bid Conference on June 18, 2019, 9:30 a.m. at the SRA Conference Room, Sugar Regulatory Administration, Araneta St., Singang, Bacolod City, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before 9:00 a.m. July 1, 2019. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on July 1, 2019 9:30 a.m. at the SRA Conference room, Sugar Regulatory Administration, Araneta St., Singcang, Bacolod City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The SUGAR REGULATORY ADMINISTRATION reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
