DILG Advisory dated 11 April 2020

DATE:

Pursuant to the issuance of the various Government agencies and Local Government Units of guidelines and protocols mandating Barangay Officials to regulate movement of individuals in its implementation on stringent social or physical distancing and to allow Frontliners and/or Authorized Persons Outside Residence (APOR) to pass through any Barangay established Checkpoints. The DILG Office of the Secretary issued an Advisory dated 11 April 2020 emphasizing the prohibition against the use of Barangay Service Vehicles in transporting Unauthorized Persons or Individuals who are not considered Frontliners, reiterating strict implementation of the Enhanced Community Quarantine and providing a list of Individuals considered as frontliners or APOR.

Further reminding the Barangay Officials to ensure compliance on <u>UNIMPEDED</u> movement of all types of cargo (food and non-food) and <u>allow passage of personnel of business establishments permitted to operate</u> during the Enhanced Community Quarantine, subject to presentation of proof of employment and residence and that <u>all Frontliners both public and private sector</u>, <u>upon presentation of any proof of Identification issued by their respective Offices</u>, shall not be required to present other types of ID card.

The **following individuals shall be considered Frontliners** or Authorized Persons Outside Residence (APOR):

D. SECURITY SERVICES

-Company Security Officers and Security Guards

F. ESSENTIAL GOODS

-Delivery personnel (2 including the driver) of cargoes.

(IATF-MEID Resolution No. 14 pertaining to Closed-in staff necessary or connected to the movement, which is granted exemption: At most three (3) personnel operating cargo delivery service vehicles for food, drinking water, medicine and other basic necessities with or without load)

Note: Any inconsistency as to the above provisions must interpreted in favor of *unimpeded movement of cargoes and its personnel*.

-Employees working at food and medical manufacturing establishments.

The Advisory, as quoted below, states that all Barangay Officials are reminded to ensure that the following are complied with:

- 1. **NO** Barangay not LGU checkpoints shall be established without the authority of the PNP.
- Ensure the <u>UNIMPEDED</u> movement of all types of cargo (food and non-food), and allow the passage of personnel of business establishments permitted to operate during the Enhanced Community Quarantine, subject to the presentation of proof of employment and residence.
- 3. **NO** Cedula or Community Tax Receipt requirement prior to the issuance of Barangay Quarantine Pass or Home Quarantine Pass or Quarantine related document.
- 4. Barangay Quarantine Pass or Home Quarantine Pass or Quarantine related document **SHALL BE FREE OF CHARGE**.
- 5. **NO** Voter's ID requirements prior to the distribution of food packs, relief goods, and the like. The LGUs must ensure however, to PRIORITIZE the indigent families or the most affected families or the most affected families within their jurisdiction.
- 6. **STRINGENT** enforcement of the "Social or Physical Distancing" in Public Markets, Groceries and in distributing relief goods or food packs.
- 7. Ensure that precautionary measures prescribed by DOH are complied with.
- 8. All "Frontliners" both in public and private sectors, upon presentation of any proof of Identification or certification issued by their respective Offices, shall not be required to present other types of ID card.

The IATF-MEID, DILG, DOH and other government agencies concerned issued various Resolutions and Circulars, and conducted information dissemination campaign, through the different social media platforms, which provide guidelines and relevant information that will guide the local officials, especially barangay officials, in the performance of their roles and responsibility to implement and the Enhanced Community Quarantine (ECQ) within their respective jurisdiction.

The ECQ guidelines and protocols mandate the Barangay Officials, to regulate the movement of individuals, to implement stringent social or physical distancing, to allow Frontliners or Authorized Persons Outside of Residence (APOR) to pass through LGU/Barangay Established Checkpoints, among others.

In this regard, all Punong Barangays and other Barangay Officials are directed to prevent the use of Barangay Service Vehicles from transporting UNAUTHORIZED PERSONS or individuals who are not exempted from the travel ban.

Barangay Officials are informed that the following individuals shall be considered Frontliners or APOR¹, such as:

- ✓ All DOH Officials and Staff
- ✓ All health and service personnel stationed at LGU Health Facilities
- ✓ All PRC vehicles bearing the Red Cross Logo and Staff with Red Cross IDs
- ✓ Core Staff from WHO Country and Regional Offices
- ✓ Doctors and their drivers
- ✓ Hospital Staff and Employees including janitorial services
- ✓ Medical Professionals and other Employees
- ✓ Private Care Givers

B. FUNERAL SERVICES

- ✓ Employees
- ✓ Immediate family of the deceased
- ✓ Officiating Priests, Imam, Pastors and other religious Ministers

C. EMERGENCY RESPONDERS

- ✓ BFP
- ✓ DRRMC
- ✓ DSWD
- ✓ DILG 911 and DILG Emergency Operations Center (EOC) Personnel
- ✓ Barangay Health Emergency Response Team (BHERT)
- ✓ LGU Officials

D. SECURITY SERVICES

- ✓ PNP, AFP, PCG, BJMP, NBI, OTS, BOC, BI, PPA, MMDA and other Law Enforcement Agency Personnel
