

INVITATION TO BID FOR THE REHABILITATION OF WATER IMPOUN (SHORT OF AWARD)

2021-SIDA-03

- 1. The Sugar Regulatory Administration, through the funding year 2021 intends to apply the sum of PhP5,000,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract for REHABILITATION OF WATER IMPOUNDING (SHORT OF AWARD) (2021-SIDA-03). Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
- 2. The Sugar Regulatory Administration now invites bids for REHABILITATION OF WATER IMPOUNDING (SHORT OF AWARD). Completion of the Works is required by December 31, 2021. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 IRR of RA No. 9184, otherwise known as the "Government Procurement Reform Act".
- 4. Interested Bidders may obtain further information from Sugar Regulatory Administration and inspect the Bidding Documents at the address given below during 8:00 a.m. - 5:00 p.m.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on September 1, 2021 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP 5,000. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 6. The Sugar Regulatory Administration will hold a Pre-Bid Conference on September 9, 2021. SRA at Bacolod Conference Room videoconferencing/web-casting via Microsoft Teams platform (link will be provided), which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before September 21, 2021, 9:00 A.M. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
