SUBJECT : SRA ONLINE PAYMENT SYSTEM CHANNELS

On December 13, 2021, SRA issued Circular Letter No. 6 Series of 2021 with the subject "**Guidelines Governing the Online Payment System for the SRA Regulatory Service Fees Through the Landbank Link.BizPortal**" providing SRA regulatory clients an online payment platform in the delivery of critical regulatory services in support to Republic Act 11032 or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018.

To further strengthen the government's thrust for the digital transformation initiatives, the Office of the President has also issued Executive Order No.170 Series 2022 on May 12, 2022, mandating all government offices to adopt digital payments for government disbursements and collections. With E.O. No.170, the SRA's online payment system has been further highlighted and promoted.

Thus, in compliance with the said Executive Order No. 170 Series 2022, SRA is reiterating the utilization of the online payment system when paying SRA regulatory service fees through the LBP Link.BizPortal. SRA is publishing the list of available payment channels covered by LBP's Link.BizPortal system as a guide to all regulatory clients when availing of the online payment system services.
