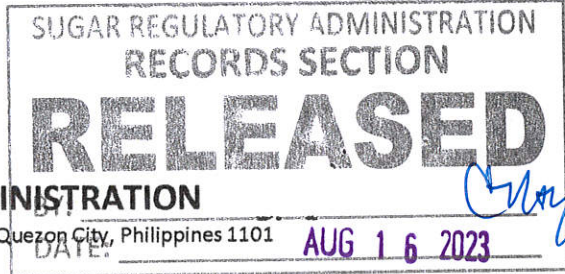

SUGAR

Relative to Memorandum Circular No. 7 Series of 2023 (Re: Verification of "A" U.S. Quota Sugar and "D" World Market Sugar Covering Crop Year 2020-2021 and Previous Crop Years), the total volume verified/confirmed "A" and "D" sugar quedans as of July 21, 2023 issued for Crop Year 2020-2021 and previous Crop Year and shall be qualified for Reinstatement per Sugar Order No. 8, s. 2022-2023 and Reclassification /Conversion per Sugar Order No. 9, s. 2022-2023 are as follows:

D	79,868.58	3,993.43


It is hereby directed that all Sugar Mills shall conduct Compulsory Disposition of all verified quedans subject to Sugar Order No. 9, s. 2022-2023 prior to the issuance of a consolidated quedan in favor of the winning bidder.

Section 2 of Sugar Order No. 4, s. 2014-2015, subject of which is the Validity and Expiration of Sugar Quedans states that "after the expiration of the re-validated quedans under this Order, sugar quedans shall be subjected to compulsory disposition under Warehouse Receipts in the absence of a provision in the milling agreement.

The subject quedans shall be bidded out not later than August 31, 2023.
